ORDER

The Governor of Haryana is pleased to promote Sh. Bharat Bushan, Senior Accounts Officer to the post of Chief Accounts Officer in the functional Pay Matrix level-12 (Twelve) from the date he assumes the charge of his new assignment.

2. The Promotion of the above said officer is subject to the condition that he will no right of seniority over Sh. K.K.Pilani, Senior Accounts Officer, if he is found fit for promotion from retrospective dates after the decision of departmental proceeding against him.

3. The promotion shall be without prejudice to the right of his senior.

4. He will be on probation for one year which can be extended up to three years.

5. The Governor of Haryana is further pleased to post Sh. Bharat Bushan as Chief Accounts Officer in the office of Director, Pt. B.D. Sharma University of Health Science, Rohtak against vacant post with immediate effect.
