Subject:- Payment of annuity to the land owner under R&R policy of Government of Haryana-----**Revoking of Black Listed order of M/s ICICI Prudential Life Insurance Co. Ltd.**

Vide this office Order dated **29.03.2013** issued under endst. No.PA/USF/63/2010 dated **11.04.2013**, **M/s ICICI Prudential Life Insurance Co. Ltd.** was black listed for a period of three years from doing any further business with the Government of Haryana or any of its Departments, Public Sector Undertakings/Autonomous bodies for intentionally delaying the entire process of distribution of annuity to the land owners and failure to carry out its commitments. Noticee was however given option to pay compounding fee in lieu of entire or a part of the black listing period within **one month** from the date of the above referred order.

In view of above option, **M/s ICICI Prudential Life Insurance Co. Ltd.** has paid requisite compounding fee worth Rs. **411.21 lacs** for the entire black listing period i.e. 3 years.

Considering above, the black listing order dated **29.03.2013** issued under endorsement No. PA/USF/63/2010 dated **11.04.2013** in r/o **M/s ICICI Prudential Life Insurance Co. Ltd.** is hereby revoked and restrictions/limitations imposed on **M/s ICICI Prudential Life Insurance Co. Ltd.** vide the above said order, will no longer be applicable.
