NOTICE/CORRIGENDUM

S.A.S. Part I and Part II (OB/LAD) Examination

Self certified applications along with declaration in the prescribed format as available on the web-site www.hrtreasuries.gov.in or alternatively available also on the web-site www.finhrv.gov.in complete in all respect and duly signed are invited from eligible candidates desirous of taking the S.A.S. Part I and Part II (OB/ LAD) Examination in terms of the following:

The application form must be accompanied with the following:

- i. Three recent passport size photograph of the applicant duly attested by the Head of respective Office at District level or above, including the Head of respective Department/ Agency.
- ii. An Indian Postal Order for the amount of Rs. 500/- (Rupees Five Hundred only) duly crossed in favour of Deputy Director, Treasuries & Accounts, Haryana and payable at Chandigarh as non-refundable processing fee (even when the permission to take the examination is denied).
- iii. A self addressed envelop (for conveying the roll number and Admit Card).

Last date for receipt of Application

The application must be made directly to the Director, Treasuries and Accounts, Haryana in a manner so as to reach his office located at 2nd Floor, 30 Bays Building, Sector 17 C, Chandigarh on or before 5.00 pm on 13.3.2009as extended from 10.03.2009. Applications reaching after the due date and time would not be considered. A duplicate copy along with all accompanying documents except the postal order must be submitted to the concerned Head of Department/ Agency through proper channel.

Eligibility

Apart from other conditions laid in this regard, to be eligible, the applicant must:

- i. Be a regular employee of the Government of Haryana or any of the other eligible bodies as listed at Annexure I on the said web-site.
- ii. Be at least a graduate from any recognised University.

- iii. Have at least a cumulative experience of three years on the eligible ministerial posts as listed at Annexure II on the said web-site.
- iv. Never in his career should have any doubt about his integrity been raised.
- v. Have earned at least 70% good and above remarks in his ACR during the immediately preceding 10 years.
- vi. Not be having any disciplinary proceeding under rule 7 (major penalty) of the P.&A. Rules or equivalent or any criminal proceeding pending before any court of law at the time of making the application.

Note: All these aspects would be certified by the respective Head of Department in due course and only such of candidates passing the exam would be declared qualified S.A.S. Part I and Part II (OB/ LAD) who possess all these eligibility criteria as well in terms of such a certification.

Conduct of Examination

The examination shall be conducted by the Director General, Haryana Institute of Public Administration (HIPA), Gurgaon on 6.4.2009 at such time and place as determined and conveyed by HIPA in due course. Only such of candidates who have been issued roll number and Admit Card by HIPA for taking the examination shall be permitted to take the exam on appointed date, venue and time. The date of exam, however, can be changed also.

Settlement of Disputes


In the event of any dispute/ grievance regarding the eligibility, conduct of exam, declaration of result or concerning any other issue related to this exam, the matter shall be referred to the Director, Treasuries & Accounts, Haryana and his decision thereupon shall be final and binding.

Miscellaneous Conditions

- i. The practice of seeking application through the Head of Department/ Agency has been dispensed with to simplify the procedure. Self certified application in prescribed form along with other necessary accompanying material must be made directly to the Director, Treasuries & Accounts, Haryana in terms of this Notice. Further, it needs to be noted that mere permission to take the exam would never carry any presumption that the eligibility stands confirmed in all respects.

Entitlement to be declared qualified would be subject to certification by the Head of the respective Department/ Agency in due course.

- ii. Applications found incomplete would be rejected straightaway and once submitted, there would be given no opportunity to modify/ rectify/ qualify/ submit fresh documents, etc, in any eventuality.
- iii. The processing fee once deposited along with the application would not be returned/ refunded in any case including even when the applicant voluntarily withdraws his candidature.
- iv. The Format of Application Form and the Annexure I and Annexure II may also be seen at the Notice Board of the Directorate of Treasuries and Accounts, Haryana.
