Subject:- Payment of Dearness Allowance to Haryana Government Employees continuing to draw their pay in the pre-revised pay scale as per 5<sup>th</sup> Pay Commission w.e.f. 01.07.2017.

Sir/Madam,

I have been directed to invite a reference to Finance Department circular letter No. 4/1/2009-5FR/13123 dated 29<sup>th</sup> April, 2017 on the subject noted above and to say that the Governor of Haryana is pleased to decide the rate of Dearness Allowance admissible to employees of Haryana Government who continue to draw their pay in the pre-revised pay scale as per 5<sup>th</sup> Pay Commission shall be enhanced from the existing rate of 264% to 268% of the pay w.e.f. 1<sup>st</sup> July, 2017.

2. The additional installment of Dearness Allowance payable under these orders shall be paid in cash to all Haryana Government employees with the salary for the month of November, 2017 to be paid in December, 2017.
3. The payment of arrears of enhanced Dearness Allowance for the month from July, 2017 to October, 2017 shall be made in the month of December, 2017.
4. The provision contained in Para 3,4,5 & 6 in FD's instructions dated 12-01-2009 shall continue to be applicable while regulating Dearness Allowance under these instructions
